

Roscommon County Transportation Authority Authorization for Release of Location Information

This Authorization for Release of Location Information (“Authorization”) is executed as of the date indicated below by the undersigned individual (“Authorizing Party”). This Authorization governs the disclosure of personal location information, as defined herein, by the Roscommon County Transportation Authority (“RCTA”) to the individuals specifically named in this document.

1. Section I: Purpose. The purpose of this Authorization is to grant consent to RCTA for the release and ongoing disclosure of the Authorizing Party’s Location Information, as defined in Section II herein, to certain designated individuals.
2. Section II: Definition of Location Information. For purposes of this Authorization, “Location Information” refers to any data, record, or report that identifies or can be used to identify the physical location of the Authorizing Party. This may include:
 - a. Real-time GPS coordinates.
 - b. Historical logs of travel or presence at specific addresses.
 - c. Check-in information from mobile applications or devices.
 - d. Map histories from navigation applications.
 - e. Any related metadata indicating movement or presence at a place.
3. Section III: Authorized Recipients. The following individuals are authorized to receive my location information as specified in this Authorization:

This Authorization is limited strictly to the individuals listed above. No other person, organization, or entity is granted access by this document.

4. Section IV: Scope and Manner of Release. RCTA may release Location Information about me to Authorized Recipients, including past and future Location Information, from the date below until the expiration or revocation of this Authorization.

5. Section V: Limitations.
 - a. This Authorization does not permit the further release, sharing, or transfer of my location information to any other person or entity by the Authorized Recipients.
 - b. Authorized Recipients must only use the information for the purposes explicitly described herein or as communicated in writing by the Authorizing Party.
 - c. Nothing in this Authorization allows for the interception, covert tracking, or unlawful acquisition of my location information.
 - d. This Authorization may not override any applicable laws, regulations, or policies governing the release of such information.

6. Section VI: Expiration and Revocation
 - a. This Authorization will remain in effect until _____ [Expiration Date], unless revoked earlier by the Authorizing Party in writing.
 - b. The Authorizing Party may revoke this Authorization at any time by submitting a signed statement of revocation to RCTA. RCTA will provide the signed revocation to the Authorized Recipients.
 - c. Upon revocation or expiration, no further Location Information shall be disclosed under this Authorization, and any information previously received must be handled in accordance with privacy obligations and applicable laws.

7. Section VII: Risks and Acknowledgment. I acknowledge and understand that:
 - a. The release of my Location Information to the Authorized Individuals may result in those individuals knowing my real-time or historical whereabouts.
 - b. There are inherent risks to my privacy and safety when sharing location data, and I assume responsibility for those risks.
 - c. Once this information is disclosed, the Authorized Recipients may not be subject to the same privacy protections as RCTA.
 - d. I am not required to sign this Authorization as a condition for receiving goods or services from RCTA.

8. Section VIII: Authorization and Signature. By signing below, I affirm that I have read and understand this Authorization, that I am acting voluntarily and without coercion, and that I grant permission for the release of my location information as described above, by RCTA, to the individuals listed in Section III. This Authorization for Release of Location Information constitutes the entire agreement between the Authorizing Party and the releasing entity regarding the disclosure of Location Information to specific individuals. No other agreements, verbal or written, shall modify the terms of this Authorization unless made in writing and signed by the Authorizing Party.
